PUBLIC COMMENT:

Mr. H. Bourguignon asked for clarification of the property that is offered to the Township by the Preservation and Wildlife Society. Information was given.

Mr. R. Steele questioned the Park Grant awarded by Burlington County. He requested to know what it was being used for. The grant is being used at the New Gretna Park at Oak Avenue--to take care of some street lighting, tree trimming, stump grinding and removal of old dead trees for trails and to provide for parking and restrooms.

Mr. L. Bourguignon asked if the township decides to do something different with the park property. Response: This was land swapped with the State of NJ for other land and is deed restricted.

Mr. L. Bourguignon noted that in his opinion the EMT courses being paid by the Township are a waste of money.

Cramer's Junkyard commented on Mr. Aaronson's letter and noted they are working with DEP and the Township on these issues.

Being no further comments the motion to close the public portion was made by Commissioner Smith, seconded by Commissioner Bethea. All in favor and public comment was closed at 9:40 p.m.
