ORDINANCE 2012-05

AN ORDINANCE AUTHORIZING THE LEASE OF A PORTION OF THE PREMISES KNOWN AS "BASS RIVER TOWNSHIP MUNICIPAL PARK" BLOCK 56, LOT 50A AND 51 TO THE JERSEY SHORE LIVE STEAM ORGANIZATION, TRADING AS THE TUCKERTON RAILROAD AND STEAMSHIP COMPANY, A NEW JERSEY NON-PROFIT CORPORATION

Mayor Cope read Ordinance 2012-05 by title. Upon the motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione Ordinance 2012-05 was approved and meeting was open for public hearing. Votes: Cope-Yes, Capriglione-Yes, Bourguignon-Yes. Comments: Mr. Leo Assur asked for more information regarding the park and if the trails are available at this time. Yes, they are. Bathrooms or meeting hall? Yes, bathrooms and possible meeting hall in the future. Mr. Rick Steele asked if any more money was available for any other park in the township. Mayor commented yes, across the street a park has been proposed to the County for funding. Mr. Steele asked if all 65 acres of the park are for the railroad. Mayor Commented no. Trails are available for public access and trails are also shared. Mr. Assur asked if horses are permitted. Mayor commented yes and added that cleanup of glass in ongoing. Being no further public comment the motion to close the public portion was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor and meeting was closed for public comment. The motion to adopt Ordinance 2012-05 was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. Votes: Cope-Yes, Capriglione-Yes, Bourguignon-Yes. All in favor and Ordinance 2012-05 was hereby adopted.

ORDINANCE 2012 – 05

AN ORDINANCE AUTHORIZING THE LEASE OF A PORTION OF THE PREMISES KNOWN AS "BASS RIVER TOWNSHIP MUNICIPAL PARK" BLOCK 56, LOT 50A AND 51 TO THE JERSEY SHORE LIVE STEAM ORGANIZATION, TRADING AS THE TUCKERTON RAILROAD AND STEAMSHIP COMPANY, A NEW JERSEY NON-PROFIT CORPORATION

Be it ordained by the Board of Commissioners of the Township of Bass River as follows: WHEREAS, the Township of Bass River is the owner of Block 56, Lot 50A and Lot 51; and WHEREAS, this property is not needed for public use; and

WHEREAS, N.J.S.A. 40A:12-14(c) permits the leasing of Township property to a non-profit corporation or association for public purpose without the necessity of public bidding; and

WHEREAS, the Township of Bass River previously entered into a lease agreement with the Jersey Shore Live Steam Organization, trading as the Tuckerton Railroad and Steamship Company, a New Jersey Non-Profit Corporation dated April 16, 2007; and

WHEREAS, the Township of Bass River and Tuckerton Railroad wish to continue to provide such activities within the community to promote learning and participation by the general public in the historical operation of live model steam engine trains; and

WHEREAS, the Board of Commissioners of the Township of Bass River believes that this activity will inure to the general benefit of the residents of the Township of Bass River as well as those of the surrounding townships;

NOW THEREFORE BE IT RESOLVED that a finding is made by the Bass River Township Board of Commissioners that the approval of this Ordinance pursuant to N.J.S.A. 40A:12-14(c) will be in the best interest of the residents of the Township of Bass River.

BE IT FURTHER RESOLVED by the Board of Commissioners of Bass River to authorize the continued leasing of a portion of Block 56, Lots 50A and 51 to Jersey Shore Live Steam Organization, trading as the Tuckerton Railroad and Steamship Company for an additional term of five (5) years for consideration of \$1.00. This lease is subject to the execution of an appropriate form of lease between the Township and Jersey Shore Live Steam Organization, trading as the Tuckerton Railroad and Steamship Company.

BE IT FUR THER RESOLVED that the Jersey Shore Live Steam Organization, trading as the Tuckerton Railroad and Steamship Company, shall annually submit a report to the Board of Commissioners of the Township of Bass River setting out the use for which the leasehold was put during each year, the activities of the lessee undertaken in furtherance of the public purpose for which the leasehold is being granted, the approximate value or cost, if any, of such activities in furtherance of such purpose, and an affirmation of the continued tax exempt status of the non-profit corporation pursuant to both State and Federal law. BE IT FURTHER RESOVLED that the Mayor and Clerk shall be authorized to execute the appropriate form of Lease in this matter.
