PUBLIC COMMENT:

The meeting was open for public comment at 7:15 p.m. upon a motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor.

Mr. Kurzrock of Little Egg Harbor asked about the situation with the property adjacent to his property. The 10 acres pond that is adjacent to his property for over 50 years was drained and is a mud flat. Pond is on Ballinger's Creek and owned by the State of NJ. Investigations of the matter show that someone took a machines/backhoe and dredged a hole in the berm causing the pond to drain. Talked to individuals from DEP and the

Township. He wrote a letter to the township requesting to be put on agenda for this evening. He would like to know if this was done under the direction of a township employee and has any permits of other work or arrangements been done. What are the plans of Bass River Township to fix the damage that was done?

Mayor said that there is an issue with flooding of septics and the leach field of Offshore Manor. The employee tried to go out and to try to clear out the Beaver Dam. Mayor met with State and walked the perimeter with the officials. Several issues that the State is dealing with. The area the township touched was state owned land. All officials have been contacted. The State did not post area but will do so in near future. In the mean time the State is doing its investigation to deal with the issue. No impact study has been done. The Township is going to wait for the investigation to be completed.

- W. Roberts said that the Township will find upon research if the leach field is failing it has nothing to do with the pond water.
- Ms. A. Chambers-Martin (Daughter of Pat Chambers) read a letter written by her mother. Property has frontage on Ballinger's Creek aka Roberts Pond. South berm damage and destruction of berm. Eco system compromised and destroyed and homeowner's property values being affected as well. Asking who gave permission.
- J. Dawson asked if the township had a time line of when this will be repaired. The cedar swamp is also draining and time is of the essence for the repair.
- B. Wurst said he was disheartened to hear about this matter and to blame it on beavers is false.
- K. Foder said that he fishes at that pond a lot. For the last 3 or 4 years the beavers have built dams close to route 9. He cleared a few limbs out of the front dam. Feels the Township did it with good intentions. He went to State, DEP and Little Egg to complain about the pond and the issue with flooding but nothing was done.
- Mr. B. Roberts said the State needs to go in and clean a lot of trash out of the culvert under Route 9.
- Mr. P. Chambers said he purchased his property because of the pond. He loves being by the pond and very upset and emotional about this issue. Correction is what is important at this point. He encouraged the Board to get the State to move this along to correct this problem.
- Mr. W. Aaronson said he would like the Commissioners to understand that this mishap is due to the fact that the Township does not have an operating Environmental Commission.
- Mr. K. Foder complained about shooting of guns behind his house in the middle of the night. He would request the township consider passage of an ordinance. Be no further comments, the motion to close the public portion was made by Commissioner

Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and public portion was closed at 7:59 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and meeting was adjourned at 8:24 p.m.
