ORDINANCE 2016-01

CALENDAR YEAR 2016 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

Mayor Cope read Ordinance 2016-01 upon second reading by title only. The motion to approve Ordinance 2016-01 upon second reading and to open the meeting for public hearing was made by Commissioner Bourguignon and seconded by Mayor Cope. All present in favor and meeting was open for public hearing on Ordinance 2016-01. Comments heard: None. Being no comments the motion to close the public hearing was made by Commissioner Bourguignon, seconded by Mayor Cope. The motion to adopt Ordinance 2016-01 was made by Commissioner Bourguignon and seconded by Mayor Cope. Votes: Cope-Yes, Capriglione-Absent, Bourguignon-Yes. All present in favor and Ordinance 2016-01 was hereby adopted.

ORDINANCE 2016-01 CALENDAR YEAR 2016 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Board of Commissioners of the Township of Bass River in the County of Burlington finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Board of Commissioners hereby determines that a 3.5% increase in the budget for said year, amounting to \$42,475.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Board of Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Board of Commissioners of the Township of Bass River, in the County of Burlington, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Township of Bass River shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5% amounting to \$42,475.00, and that the CY 2016 municipal budget for the Township of Bass River be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

ORDINANCE 2016-02

AN ORDINANCE OF THE TOWNSHIP OF BASS RIVER, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING AND **SUPPLEMENTING** TITLE "ANIMALS", CHAPTER 6.08 OF THE TOWNSHIP CODE, ENTITLED "DOGS ANIMALS" **OTHER** AND ADDING **SECTION** 6.08.075 **ENTITLED** "TETHERING DOGS"

Mayor Cope read Ordinance 2016-02 upon first reading by title only. Mayor Cope had some concerns with the Ordinance with regard to the length of time a dog can be tethered. After further discussion it was agreed to table the ordinance and address the issue of length of time. The motion to table Ordinance 2016-02 upon first ready by title only was made by Mayor Cope and seconded by Commissioner Bourguignon. Votes: Cope-Yes, Capriglione-Absent, Bourguignon-Yes. All in favor and Ordinance 2016-01 was hereby tabled.

ORDINANCE 2016-02

AN ORDINANCE OF THE TOWNSHIP OF BASS RIVER, COUNTY OF BURLINGTON, STATE OF **AMENDING NEW** JERSEY, **SUPPLEMENTING** TITLE 6, "ANIMALS", CHAPTER 6.08 OF THE TOWNSHIP CODE, OTHER ANIMALS" **ENTITLED** "DOGS AND ADDING **SECTION** 6.08.075 **ENTITLED** "TETHERING DOGS"

BE IT ORDAINED by the Mayor and Commissioners of the Township of Bass River, County of Burlington, State of New Jersey, as follows:

SECTION 1.

Title 6, (Animals), Chapter 6.08 of the Township Code of the Township of Bass River, entitled "Dogs and Other Animals" is hereby amended to add the following Section:

§ 6.08.075 Tethering Dogs.

- A. It is unlawful to chain or tether unneutered/un-spayed dogs in any manner and/or at any time within the Township.
- B. Neutered/Spayed dogs may be tethered under the following circumstances:
 - The Tether must be at least 15 feet long and have operative swivel on both ends, weigh no more than 1/8th of the dog's weight and be attached to a properly fitting collar or harness.

- 2. The collar used for tethering may not be a choke chain collar, slip collar or prong collar.
- 3. The tether must allow the dog access to proper shelter, sufficient food and sufficient water.
- 4. The tether may not be used in any area where it may become tangled around object, such as, but not limited to, a tree, pole, fence or stake.
- 5. The tether cannot inhibit the movement of the animal's limbs or cause injury, harm, entanglement or strangulation.
- 6. The tether must restrain the dog within the bounds of the owner's or caregiver's property.
- 7. The tether must terminate no less than five (5) feet from any fence, pool, wall, vehicle, tree or other object or obstruction upon which any animal may harm itself.
- 8. Dogs may not be tethered for no more than four (4) consecutive hours in any twenty four hour period of time and never between sunset and sunrise.
- C. When a violation of this provision occurs, an animal control officer or law enforcement officer is authorized to document the circumstances and evidence, take reasonable measures to remove the animal from the tether, take as evidence, and take the animal to the pound.
- **Section 2:** All other Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- **Section 3.** If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.
- **Section 4.** This ordinance shall take effect 10 days after final passage and publication according to law.

PUBLIC COMMENT:

The meeting was open for public comment at 7:25 p.m. upon a motion by Commissioner Bourguignon, seconded by Mayor Cope. All present in favor.

C. Bitzberger commented that at the last meeting there was requests to have the Tax Assessor attend this meeting to make a report on the Viking reassessment. She questioned why he was not present at this meeting as requested. Solicitor O'Connor said that she made that call and the Tax Assessor is not permitted to appear before the public for such a case as Viking with regard to their being a possible appeal in the future. The assessor cannot entertain the public on the matter. Bs. Bitzberger asked what the entire reassessment of Viking would be at this time. Mayor said she believes that the reassessment if \$22.7 million. Ms. Bitzberger commented the total facility if 700,000 square feet. Mayor said assessor said it was actually 500,000 square feet. There is work at Viking that is not yet completed that will be assessed next year. If Viking were to appeal than the Township would consider a third party to reassess property. Mr. Aaronson asked if he could talk to Jay Renwick about the reassessment and Solicitor said that it would be more appropriate to go to the County tax Board. Mr. Aaronson feels that the facility should be assessed at \$50 million. That is equal to \$100/square foot construction costs.

J. O'Brian asked what the source of the information that the Board of Commissioners uses for the formulas. Where does this information come from? The Solicitor said it is based on legislation. He feels that it should be based on what can be used or not sued. Solicitor said that this is something that needs to be done in the State not here. Viking Yacht can appeal and this would be done with the State. Mayor said that if anyone needs more information on this appeal and Viking that they should contact the County Tax Board. Ms. Bitzberger asked if this number provided by the Assessor is for the marina and manufacturing. Mayor said yes it would appear to be both 26/2 and 26/8 are the blocks and lots.

C. Bitzberger reported for the Beautification Commissioner that the flags are down and the welcome sign close to the parkway is getting bad and needs repairs. Mayor requested prices for town to get new sign prices from Artcraft Sign.

Mayor Cope commended the Fire Company and Public Works on their efforts during the most recent snow storm.

B. Adams said that April 23 at 11 a.m. will be ground breaking for the memorial garden at the North Maple Park.

K. Rose commented on State Police responses and feels that we can't count on them responding to a call.

N. McCarten commented on the Burlington County meals on wheels program. There are a lot of seniors not getting food for the day. They don't know how to access it. Mayor is attempting to get a better list of seniors. Ms. McCarten said the Friendly Seniors group would attempt to get a list.

Be no further comments, the motion to close the public portion was made by Commissioner Bourguignon, seconded by Mayor Cope. All present in favor and public portion was closed at 8:12 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Mayor Cope. All present in favor and meeting was adjourned at 8:12 p.m.
