# GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT RESOLUTION 2016-49

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2015 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and,

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and,

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations, and,

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

NOW, THEREFORE BE IT RESOLVED, That the Board of Commissioners of the Township of Bass River, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

#### PUBLIC COMMENT:

The meeting was open for public comment at 7:43 p.m. upon a motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor.

Ms. N. McCarten commented on the look of the town. She feels that it look dead. She would request Tom Cramer keep his cars and trucks back off the road and behind the fence at his Junkyard.

Mr. W. Aaronson commented on Cramer's Junkyard and said the township needs to hold him accountable before the town issues him a new license.

Mr. W. Aaronson asked about the tax base, the state and the Pinelands Commission. He feels that a huge disservice was done by drawing the line for the preservation zone from the Parkway/West. Feels it should have followed State Road instead of the Parkway. He also thinks there should be more research on campgrounds and the fixed number and the number of individuals that live there year round. He also feels that \$18/resident fee be reviewed.

Mr. W. Aaronson asked about the Oak Avenue Park and the status of the Jersey Shore Live Steam. Solicitor is trying to get more information on getting them cheaper insurance. At the moment the group is paying month to month for insurance. He asked if this is an asset to the town. Mayor said that it is actually a nice addition for the town with its Halloween program, the Christmas program, etc. Give the youth of the community

pride to keep the park clean. Mr. K. Foder feels that before the town give more money to the Park they should consider putting more money toward the fire company.

Mr. Faulkenberg made comments about traffic on 9 and dangerous conditions by the "Mansion" wall. Also commented on recent accidents in the area.

Mr. B. Curtain asked about the In-Rem Foreclosures. Mayor explained the process the town is going through to complete the task. This will be an ongoing project to close out a batch every year.

Ms. C. Bitzberger thanked Commissioners for giving increases for DPW. She thanked Anthony for negotiating and working with A-E. Stone and getting a new handicapped walkway installed at the park.

Be no further comments, the motion to close the public portion was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and public portion was closed at 9:15 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and meeting was adjourned at 9:15 p.m.
