## PUBLIC COMMENT:

The meeting was open for public comment at 7:25 p.m. upon a motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor.

- M. Assur commented on the state \$.23 gas tax increase and the idea that the funds are going to fund restoration of a light house in Salam county are upsetting to her.
- C. Bitzberger commented the new welcome signs in town look great. She also asked if there was any feedback on the new Pinelands Scenic Byways signs in town. Mayor said yes and all feedback so far was positive.
- W. Aaronson questioned the tax sale certificates and the sale of the land. Solicitor said the township is waiting for the final judgment from the County and then the land will be owned by the township at that point.
- W. Aaronson asked if the Commissioners made any consideration in the matter of the Environmental Commission. Solicitor said we need to have a minimum of 5 members for the Environmental Commission. This is what the state law requires. Further consideration on the matter is ongoing.
- C. Bitzberger commented on the referendum question for the Pinelands School improvements. She asked what is the consensus and feedback. Commissioner Bourguignon feels the State should pay for the repairs as needed and not put in additions to the project at the expense of the tax payers. Ms. Bitzberger feels the commissioners should meet with members of the Pinelands Board of Education to discuss along with members of Little Egg, Tuckerton and Eaglewood Townships.

Be no further comments, the motion to close the public portion was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and public portion was closed at 7:59 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All present in favor and meeting was adjourned at 7:59 p.m.
