It is in the best interest of The Township of Bass River, a corporation of the State of New Jersey, to obtain a grant from the State of New Jersey in the amount of approximately  $\frac{$3,000 - 10,000}{10,000}$  to fund the following project: Volunteer Fire Assistance.
