#### PUBLIC COMMENT:

The meeting was open for public comment at 7:47 p.m. upon a motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor.

Mr. Courtney asked why the fire siren is on the ground at the fire house. Chief Wetmore said there was a squirrel's nest in it. It was pulled down and needed repairs.

Mr. Foder asked why the property next door to his is not maintained.

Ms. Van Orden complained about trash and branches at the leach field property bordering her property. She requested Township to send the employees out to trim trees and collect trash.

Mr. Assur asked about the tax increase and asked Mayor to explain. Mayor said there is no litigation related to this increase. The township has not raised taxes in years. Also used to get more state aid that we no longer receive as much as we should. In addition State Aid to the schools were decreased over the years. Therefore, we inherited a cap that the township could not exceed. This is a one-shot for local municipal taxes and should not be increases for at least a period of 5 years.

Mr. Rothschild asked about procedure for a farmland assessment. Mayor said he would have to file a form every year with the tax assessor stating how much is being generated.

Mr. Aaronson asked about the resolution appointing bond council. Why is this being done? CFO has instructed the Mayor that it is required by the State.

Ms. Bitzberger commented on the school debt at approximately \$800,00. She asked who will pay this debt. Mayor said the tax payers do. She would recommend a revaluation.

Mr. Aaronson agreed with Ms. Bitzberger. He feels he issue is the buildings in the town that do not have permits and built illegally and therefore not assessed. He feels that Viking should be assessed at least \$100,000,000 based on construction cost per square foot. He would suggest hiring a 3<sup>rd</sup> party appraiser. Solicitor said this would be considered a spot assessment.

Mr. Courtney asked what chemicals the State DOT sprayed on Route 9. Commissioners to try to find out.

Kevin Groff asked if the township as taken over Chips Folly Road and did the Township pay to redo it? Mayor said yes it is a township road and was repaved with a Grant from NJ DOT.

Being no further comments, the motion to close the public portion was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor and public portion was closed at 8:38 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor and meeting was adjourned at 8:38 p.m.
