A RESOLUTION SUPPORTING THE NEW JERSY DEPARTMENT OF TRANSPORTATION'S (NJDOT) RECOMMENDATION FOR A TEMPORARY TRAFFIC SIGNAL ON STATE HIGHWAY ROUTE 9 NEAR JOBS CREEK BRIDGE IN THE TOWNSHIP OF BASS RIVER, STATE OF NEW JERSEY

WHEREAS, the Township of Bass River Board of Commissioners has been notified by the State of New Jersey Department of Transportation that the installation of a portable, temporary traffic signal will be necessary in order to complete the Jobs Creek Bridge replacement project; and

WHEREAS, Township officials have met with the NJDOT, and the contractor completing the bridge replacement project, to review and discuss all alternatives available for traffic regulation during this replacement project; and

WHEREAS, NJDOT has requested a formal concurring resolution by the governing body in support of the NJDOT plan.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Township of Bass River, in the County of Burlington, State of New Jersey that it hereby approves the NJDOT plan to install a temporary, portable traffic signal on State Highway Route 9 near the Jobs Creek Bridge replacement project.

A RESOLUTION RECOGNIZING THE EDWIN B. FORSYTHE NATIONAL WILDLIFE REFUGE ON ITS 80TH ANNIVERSARY

WHEREAS, the Edwin B. Forsythe National Wildlife Refuge was first established as Brigantine National Wildlife Refuge in 1939; and

WHEREAS, today the refuge encompass nearly 48,000 acres of habitat that is critically important for migratory birds and wildlife, especially the federally listed Piping Plover; and

WHEREAS, the 50-mile-long site supports the National Wildlife Refuge System's six priority public uses of wildlife observation and photography, hunting, fishing, interpretation and environmental education; and

WHEREAS, the refuge is visited by over 250,000 people each year who engage in world-class birdwatching and wildlife photography; and

WHEREAS, Bass River Township contains over 2,500 acres of this Jersey Shore treasure.

NOW, THEREFORE, the Mayor and Council of Bass River Township, County of Burlington and State of New Jersey, do hereby congratulate the Edwin B. Forsythe National Wildlife Refuge on its 80th Anniversary.

NEW BUSINESS:

1. Introduction of the 2019 Municipal Budget: Township Auditor and Township CFO were in attendance to explain the budget and answer questions. Township Auditor, Kevin Frenia, explained this budget will include an increase of .21 cents. This is due to the continued loss of state aid and lack of rateables in the Township and not due to the Township expenditures. The expenses remain the same with very little increase, if at all. Also in attendance at the meeting was the administrator of Bass

River Elementary School as well as the Township BOE Rep for Bass River Township. Both responded to various questions regarding the schools.

Upon a motion by Mayor Cope and seconded by Deputy Mayor Capriglione, the budget was introduced and approved by title. Public hearing is schedule for the June regular meeting. Votes: Cope-Yes, Capriglione-Yes, Bourguignon-Yes. All in favor and 2019 municipal budget was hereby approved upon first reading.

PUBLIC COMMENT:

The meeting was open for public comment at 8.08 p.m. upon a motion by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor.

- C. Bitzberger questioned whether the Mayor investigated the resignation of Mr. Anderson as President of the Fire Company. Mayor Cope said she has not because it is felt that it is a fire company issue and they are a separate entity. Ms. Bitzberger requested a representative of the fire company attend a meeting to provide updates to the public. By that she is specifically requesting the President attend.
- C. Bitzberger requested the Board to withhold renewal of Cramer's Junkyard License. She noted the numerous violations at the junkyard that should be addressed. Cars are in the neighboring driveways. She is requesting the code enforcement officer go out to the property.
- K. Foder said there is a house on Birch and Ash with cars jacked up and looks like a junkyard. Code Enforcement to visit. He also noted that the empty lots in offshore manor are in bad shape.
- L. Assur asked what the town is doing to generate revenue; other than the State Police writing tickets. He suggested fixing up these corner lot properties and make it easier for people to have stay at home businesses or a business in the township.
- T. Williams suggests applying to the State for water and sewer in town.
- K. Foder asked if Viking Yacht is paying what they should be paying in taxes. Solicitor said that according to our Tax Assessor they are paying what they should be.

Being no further comments, the motion to close the public portion was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor and public portion was closed at 8:30 p.m.

Being no further business to come before the Board the motion to adjourn was made by Commissioner Bourguignon, seconded by Deputy Mayor Capriglione. All in favor and meeting was adjourned at 8:30 p.m.
