K. Foder reported that dumping is being done back by the leach field in Offshore Manor. Mr. Foder requested a street light be installed by his house on Jericho Road.

Mr. Aaronson asked if the Township required a permit to solicit in the Township. No the Township does not require such a permit.

Ms. Bitzberger is concerned about selling land to the State. She commented that the Township should consider suing the state for the fair share of PILOT funding.

Mr. Foder feels that State Police stopping in the Township are ridicules.
