WHEREAS, there exists a need to repave Amasa Landing Road from the intersection of Amasa Landing Road and Cramer Road to the end of Amasa Landing Road at the intersection with State Route #9; and,

WHEREAS, this project will improve the condition of the road and promote safe transit through the township.

NOW, THEREFORE, BE IT RESOLVED that Commission of the Township of Bass River formally approves the grant application for the above stated project.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to submit an electronic grant application identified as **MA-2021-Amasa Landing Road Phase II–00254** to the New Jersey Department of Transportation on behalf of the Township of Bass River.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of the Township of Bass River and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.

WHEREAS, NJS 40A-87 provides that the Director of the Division of Local Government Services may approve the increase of any special item of revenue in the budget of any county or municipality when such item shall have been made law and the amount thereof was not determined at the time of the adoption of the budget.

NOW, THEREFORE, BE IT RESOLVED that the Township of Bass River, County of Burlington hereby requests the Director of the Division of Local Government Services to approve the increase of an item of revenue in the budget of the year 2020 in the sum of \$1589.43; which item is now available as a revenue for the 2017 Recycling Tonnage Grant pursuant to the provisions of statue; and

BE IT FURTHER RESOLVED that a like sum of \$1589.43 be and the same is hereby appropriated under the caption of the 2017 Recycling Tonnage Grant.

EQUIPMENT PURSUANT TO THE INTERLOCAL SERVICES ACT N.J.S.A. 40:8A-1 et. seq.

The motion was made by Mayor Cope, seconded by Deputy Mayor Bourguignon to approve Resolution 2020-44. Votes: Cope—Yes, Capriglione-Yes, Bourguignon-Yes. All in favor and Resolution 2020-44 was hereby approved.

RESOLUTION NO. 2020-44

A RESOLUTION AUTHORIZING THE TOWNSHIP OF BASS RIVER
TO EXTEND THE SHARED SERVICES AGREEMENT WITH
THE BOROUGH OF TUCKERTON FOR THE SHARED USE OF PUBLIC WORKS EQUIPMENT PURSUANT
TO THE INTERLOCAL SERVICES ACT N.J.S.A. 40:8A-1 et. seq.

WHEREAS, the Bass River Township Board of Commissioners recognizes the need to provide the residents of the Township with appropriate cost savings measures and the need to take advantage of opportunities to provide cost savings in the administration of local government services for the benefit of all residents; and

WHEREAS, pursuant to the Uniform Shared Services Act, N.J.S.A. 40A:65-1 et seq., any municipality of the State may enter into a contract with any other municipality for the joint provision of any service that any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the Township of Bass River and the Borough of Tuckerton have previously entered into a Shared Services Agreement that covers the shared use of public works equipment dated October 3, 2011. That agreement has expired and both the Township and the Borough wish to continue the prior relationship for shared services by entering into the new lease extension for the shared use of public works equipment; and

WHEREAS, The Township of Bass River and Borough of Tuckerton have negotiated the terms and conditions of an agreement for the provision of such services as detailed in the attached Shared Services Agreement and lease extension; and

WHEREAS, the Township of Bass River evidences its desire to enter into such Agreement through passage of this resolution; and

WHEREAS, the parties have agreed to participate in the Shared Services Agreement between the Township and the Borough and enter into the agreement establishing the respective rights and obligations of the parties regarding this Shared Services Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Township of Bass River Board of Commissioners that:

- 1. The attached Shared Services Agreement and lease extension between the Township of Bass River and the Borough of Tuckerton shall be effective according to its terms.
- 2. The Mayor of the Township of Bass River is hereby authorized to sign, seal, execute and witness/attest the Agreement.
- 3. The Mayor and Township Clerk are authorized to take any action necessary to implement the terms of the Shared Services Agreement.

ORDINANCE 2020-04

AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT BETWEEN BASS RIVER TOWNSHIP AND LESLIE LUSTBADER FOR THE LEASING OF PROPERTY LOCATED ON NORTH MAPLE AVENUE, NEW GRETNA, BLOCK 54, LOT 2, BASS RIVER TOWNSHIP,

Mayor Cope introduced Ordinance 2020-04 on first reading by title only. The motion to approve Ordinance 2020-04 on first reading by title was made by Mayor Cope, seconded by Deputy Mayor Bourguignon. All in favor and Ordinance 2020-04 was hereby approved upon first reading by title only with public hearing and adoption scheduled for the July regular meeting.

ORDINANCE 2020 - 04

AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT BETWEEN BASS RIVER TOWNSHIP AND LESLIE LUSTBADER FOR THE LEASING OF PROPERTY LOCATED ON NORTH MAPLE AVENUE, NEW GRETNA, BLOCK 54, LOT 2, BASS RIVER TOWNSHIP, NJ

WHEREAS, the Township of Bass River is a party to a lease agreement, dated April 1, 2000, with Leslie Lustbader, owner of property located at North Maple Avenue, known as Block 54, Lot 2 on the Township of Bass River tax map (hereinafter the "property") for the leasing of the municipal parking lot; and

WHEREAS, this lease has expired and the parties wish to enter into a new lease agreement; and

WHEREAS, N.J.S.A. 40A:12-3 permits the Township to acquire property as may be necessary for the performance of its functions, including land for parking facilities to be used in connection therewith; and

WHEREAS, the Township of Bass River would like to entered into a Lease agreement with Mr. Lustbader to continue the leasing of the aforementioned property; and

WHEREAS, the Township of Bass River wishes to continue to provide the community with the aforementioned parking facility to access the Township building and park.

NOW THEREFORE BE IT RESOLVED that a finding is made by the Bass River Township Board of Commissioners that the approval of this Ordinance pursuant to N.J.S.A. 40A:12-3 will be in the best interest of the residents of the Township of Bass River.

BE IT FURTHER RESOLVED by the Board of Commissioners of Bass River to authorize the leasing of the property located on North Maple Avenue, known as Block 54, Lot 2 from Leslie Lustbader, for a term of five (5) year for consideration of \$2,500.00 per year. This Ordinance is subject to the execution of an appropriate form of lease between the Township and Leslie Lustbader.

BE IT FURTHER RESOVLED that the Mayor and Clerk shall be authorized to execute the appropriate form of Lease in this matter.

ALL OF WHICH IS ADOPTED this 1st day of June, 2020, by the Bass River Township Board of Commissioners.

- K. Swanseen said the Presp. Church would like to replace the ball box with a park bench for the basketball court. The ball box blew apart during the last windstorm. Clerk to get prices for the bench and email over to Mr. Swanseen.
- B. Curtain asked if the Township was still going to receive the PILOT funds from the State. Mayor said that yes, as of right now we are but not until October.
- C. Bitzberger noted that tree cutting project on East Greenbush Road looked terrible. No stumps have been removed nor any replanting done. Mayor will reach out to DEP.
- C. Bitzberger asked if the Board of Commissioners were going to have meetings for school. Mayor said no. The Board of Education was going to hold these meetings.
- H. Rothschild thanked the Board for putting in another 4 years.
- L. Assur asked what ideas people have for the school building. Mayor Cope said the BOE is still trying to formulate a plan.
- M. Assur asked about the primary election. It was noted the election has been moved by Governor's Executive Order to July 7th. Ballots are mail in.
- C. Bitzberger asked if the school board owns the school and it needs approval, would school come to the Township for funds to fix it up. Deputy Mayor said students aren't there anymore; therefore, it would not be township responsibility.

Be no further comments, the motion to close the public portion was made by Deputy Mayor Bourguignon, seconded by Commissioner Capriglione. All in favor and public portion was closed at 7:40 p.m.

Being no further business to come before the Board the motion to adjourn was made by Deputy Mayor Bourguignon, seconded by Commissioner Capriglione. All in favor and meeting was adjourned at 7:40 p.m.
