APPROVAL OF MINUTES:

Minutes of the regular meeting on November 6th and the Special Meeting that followed were presented to the Commission for review. Resolution #75-2023 authorizing an online auction of property no longer used by the Municipality, for public use. Gov Deals was presented to the Commission by Mayor Cope and moved by her as well. Commissioner Capriglione seconded with no discussion needed all voted in favor.

Resolution#76-2023a Resolution by the Township of Bass River for the transfer of funds in the current year of the 2023 Budget. The amount of the transfer was \$66,625.00 was for salary, clerical, Planning/Zoning, Tech, etc., Mayor Cope moved Commission Capriglione second, and all voted in favor.

Resolution#77-2023 is a Resolution requesting a 6-month extension. Of time for an award of a Construction Contract for the FY2022 Municipal Aid Grand Funded Project.

Resolution#78 - 2023 awarded a contract pursuant to N.J.S.A.40:A11-3 for the disposal of solid waste to Mathis Construction. Mathis Construction was the only bidder. Deputy Mayor Bourgunion was seconded by Commissioner Capriglione and all voted in favor.
