ORDINANCE #2 OF 2023 OF THE TOWN OF BASS RIVER AMENDING TITLE 17 OF THE BASS RIVER TOWNSHIP CODE, COUNTY OF BURLINGTON, AND STATE OF NEW JERSEY. INTRODUCED FEBRUARY 6TH, 2023.

To amend Title 17, Zoning. Of the code of The Township of Bass River in response to the completion of the Master Plan Re-examination. Second Reading March 6th, 2023.
