Chris Pinella, asked if revisions have been made to the zoning maps and ordinances more specifically with regards to commercial property.

The Solicitor stated the township has adopted an ordinance for all zoning regulation changes and the new map is being worked on by the engineer.

Josh Collins, 5625 Route 9 asked since the town adopted new ordinances regarding stormwater, will him pumping water that is flooding his property into route 9 cause a fine to him.

Township Solicitor asked for him to come see her after the meeting as there is regulations regarding that once the ordinances are adopted, but she would like to research the question and give him the correct answer.

Howard Rothchild asked is the township will have to purchase a street sweeper because of the stormwater regulations.

Township Clerk stated that is not mandated at this time.

There being no further comments or questions, Mr. Bourguignon moved, second by Mr. Adams that the public portion be closed. It was so moved.
