# Bass River Township Planning Board February 17, 2011

The regular meeting of the Bass River Township Planning board was held on February 17, 2011 in the Municipal Building and was called to order at 7:02 PM. The meeting was opened with the flag salute. 1. Stormwater Management Plan Public Hearing: Engineer Kris Kluk explained that this plan was imposed on the township by the NJ DEP. Flooding from years ago within the township was mentioned and this plan does not apply to something like that.
